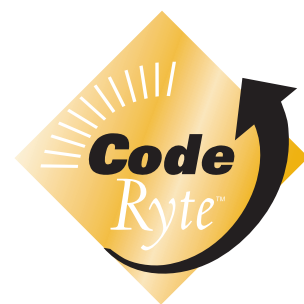
### Streamlined from end to end

CodeRyte's NLP engine was built for compliance based on national coding guidelines including ICD-9-CM Official Guidelines for Coding and Reporting, CPT published by the AMA and more than a dozen other related, payer and specialty publications.

CodeRyte codes medical records based solely on the language and evidence contained in a report. Our NLP engine automatically checks every report for evidence to assign codes. It is continually updated so that no matter when a report is processed, codes are appropriate based on date of service. The engine always codes the same report the same way, removing the natural variability introduced by human coders.

CodeRyte evaluates the complete record and ensures all procedures will be coded. The software easily accounts for all procedures and nuances in physician language such as negation, context and time reference. CodeRyte can also help you identify patterns of deficient documentation in medical dictation. This allows you to offer valuable feedback to physicians about documentation habits, further improving compliance.

### **Accommodating preferences**

CodeRyte is unique in its ability to offer coding based on clients' internal policies or payer requirements. While all clients' reports are coded using national coding guidelines, clients can request their output be tailored for their specific coding policies. Such preferences are only applied to the client that requested them. Those preferences never affect the way the application works for other clients.

For example, CodeRyte often receive reports with exam title stating "two-view test," but the body of the report doesn't indicate the number of views. Some clients tell us that they want reports like this to be coded as a two-view test (71020), but others prefer to code only from the dictated portion of the report with the lower number of views (71010). Compliance guidelines support either approach and we are able to tailor each client's output accordingly.

### **Thorough auditing**

CodeRyte constructed its application around the ability to audit, following OIG guidelines and other best practices. CodeRyte's one-of-a-kind prospective auditing allows you to closely monitor your coders' accuracy by auditing reports before they go to billing. Reports that meet your audit criteria are automatically moved to a special queue upon approval by your coders for auditing. They then go to billing once your auditor confirms or adjusts the codes. Our integrated retrospective auditing allows you to perform traditional audits of reports based on your specific parameters.

### **Stellar client service**

CodeRyte offers a team of coding and account professionals for every client – before, during and after implementation. Each one of CodeRyte's clients has a dedicated Account Executive who is their main CodeRyte contact.
